# Minutes PARK ADVISORY COMMITTEE SPECIAL MEETING

Tuesday, May 8, 2018

#### Call to Order

The Special meeting of the Park Advisory Committee was called to order at 7:06 pm.

#### Roll Call

Committee Members: Pat Tierney (Chair), Nancy Marsh (Vice Chair), Susannah Cantrell, Paul Koelsch, Owen Moore, Fran Pollard, and Dale Ross.

Staff: Delia Comito (GCSD).

#### **GENERAL PUBLIC PARTICIPATION**

Sam Herzberg, from San Mateo County Parks, mentioned that the service agreement between the District and the County had expired, and suggests PAC recommending renewal to the Board. That will allow him to continue to work with PAC and provide guidance.

#### <u>ACTION ITEMS</u>

1. Approve April 10, 2018 Meeting Minutes.

Some changes were made to Item 5 of the minutes.

**ACTION:** Member Marsh moved to approve the minutes as amended. (Marsh/Ross). Approved 7-0.

#### 2. Consider and Approve 2018 Summer Special Events.

Staff initiated the discussion by reporting that the District's liability insurance carrier, CSRMA (Alliant), indicated that it would not cover "high risk" events without the insurance Board's approval. The result would be to eliminate about half of the planned events such as the edible plant walk, biking, and yoga, assuming it would take some time to obtain approval. Tierney declared the problem "unacceptable," and made a recommendation to the Committee to approve the summer events and guide as is. A discussion ensued.

**ACTION:** Tierney moved to approve the 2018 Summer Special Events and guide as presented, with nine programs, and to forward the information to the Board Communications Ad Hoc Committee. (Tierney/Marsh). Approved 7-0.

Tierney added further that the removal of any events due to the lack of insurance coverage was unacceptable and frustrating, and he urged the District to resolve the problem.

### 3. Consider Subcommittee Recommendations for District Newsletter and Webpage.

The subcommittee of Tierney and Marsh reviewed the draft newsletter. The Committee held a discussion and some changes were made.

**ACTION:** Member Pollard moved to approve the newsletter with the changes discussed for final submittal. (Pollard/Koelsch). Approved 7-0.

The Committee held a discussion regarding adding links to the website, the changes needed for the summer program registration, and notification capabilities.

ACTION: Pollard moved to approve the webpage with the changes made to the newsletter and adding notifications. (Pollard/Marsh). Approved 7-0.

### 4. Consider Possible Short-Term Lease of Cabrillo Unified School District (CUSD) EG Surplus Property.

The Committee held a discussion regarding continued interest in pursuing a lease of the CUSD property for other recreational uses, since the Quarry Park Master Plan will include a bike pump track, which the GCSD has promised to fund. Sam Herzberg of San Mateo County expressed his interest in starting dialog with the District regarding the pump track planning.

**ACTION:** Member Marsh moved to approve recommending Board approval to pursue a short-term lease of the CUSD property for recreational use. (Marsh/Koelsch). Approved 6-0-1. Pollard abstained.

#### 5. Consider Approving Parks and Recreation Priorities for 2018.

Chair Tierney reviewed the priority list provided and the committee discussed making some changes.

**ACTION: Member** Pollard moved to approve the revised priority list as discussed. (Pollard/Ross). Approved 7-0.

#### 6. Discuss next PAC meeting date.

The Committee decided to hold the next meeting on 6/12/18.

I've taken a look at the new web page. The static Parks and Recreation page looks pretty good. I notices that the photo of PAC is not included - maybe due to space? The main concern with that is that as a result the names of the 2018-2019 PAC members are left out. I suggest that you add, prior to "2018 agendas have so far ... " this line:

"2018-2019 PAC members include Paul Koelsch, Owen Moore, Dale Ross, Susannah Cantrell, Pat Tierney (Chair), Nancy Marsh (Vice Chair) and Fran Pollard."

Of greater concern is the Connection to Recreation link. It appears that the new page used the Newsletter copy rather than the copy that was written for the web (page 5-8 of the attachement). The web-specific copy included more information for each event for suitability (including the note that the Legal Counsel wanted re parents accompanying any children under 18) and critically, the meeting place for each event. In addition the section regarding how to register and to download the Waiver/Photo Release (I believe Pat supplied this at some point) is not there at all.

### GCSD Works to Provide Parks and Recreation Services

The Granada Community Services District (GCSD) gained parks and recreation jurisdiction on October 1, 2014 for the unincorporated areas of El Granada, Miramar and Princeton by a positive vote of 60% of the voters in the District. This reorganization allows the district to provide parks and recreation services in addition to the sewer, solid waste and recycling services it currently provides to over 2,500 residences and businesses in the District.

The parks and recreation function is 'unded by utilizing a portion of GCSD's share of property tax revenues, not from sewer charges. GCSD's goal is to provide parks and recreation services that benefit the GCSD community, with a commitment to robust neighborhood outreach on new projects.

GCSD owns the undeveloped "Burnham Strip" property along Obispo Road between Coronado Street and Avenue Alhambra in El Granada, which may be developed as an El Granada gateway park. In 2017 an additional parcel, next to the preschool, was purchased in order to maximize the area available to develop as a park. GSCD is now beginning the process of seeking public input regarding the amenities and design of the future Burnham Park.

Additional potential park areas are a small parcel on Capistrano Road in Princeton and the medians in El Granada, which are owned by San Mateo County (SMC). GCSD and SMC completed a Permit Agreement in February 2018 which allows the District to make improvements to the El Granada Medians. GCSD may implement landscaping, seating, tree management, and active and passive recreational improvements on these properties, following an open and transparent community outreach process.



The District is now responsible for parks, recreation, garbage and recycling services in the unincorporated areas of El Granada, Princeton, Princeton-by-the-Sea, Clipper Ridge, and Miramar. The parks function is funded by property tax revenues, not by sewer charges.

The District is also responsible for the sewage collection system and disposal for approximately 2,500 residences and businesses in the District as well as the northern portion of the City of Half Moon Bay. Garbage and recycling services are provided by Recology of the Coast under a franchise agreement with the Granada Community Services District. 🦹

Hi Chuck, Barbara,

Please find attached our proposal for the Medians Concept Designs. Now knowing that not much existing survey base information is available, we have allocated about 5 hours of our time coordinating the acquisition of a complete topo survey. If some additional information is discovered before we commence our process, please let us know and we can make adjustments to our work scope. From some initial discussions with potential surveyors, it may take between 1-1/2 to 2-1/2 months to acquire the survey.

Our process in developing the Concept Designs will be very similar to that of Burnham Park. We have allocated for a Site Constraints Map, 2-3 Concepts, a couple of meetings, and design refinements. IF we happen to combine meetings or presentations with Burnham Park, there could be some cost savings.

At this time we do not think that it is appropriate to provide a proposal for the next step in the Design Phase with Burnham Park. I think once we have full input from the June 16th event, we will be able to better gauge the continuation of the process and its related efforts.

Please feel free to call if you have any questions. As discussed, we are comfortable with implementing this work as a change order or "additional services" to our original agreement.

Thank you for the continued opportunity to provide design services for the GCSD. We appreciate the time that Leonard, Nancy and Pat took to walk the medians with us and to explain the design program and opportunities

Please find below an outline of our Conceptual Design services, broken down into tasks and deliverables:

#### **CONCEPTUAL DESIGN PHASE**

#### 1. Tasks:

- A. <u>Project Research:</u> Collect base data, define scope of and solicit on behalf of GCSD for a topographic and boundary survey, conduct a site reconnaissance, photo documentation, and check applicable San Mateo County codes.
- B. <u>Analysis:</u> Synthesize existing data and evaluate prior to commencing design.
- C. <u>Concept Development:</u> Develop 2-3 site concepts along with plan graphics suitable for preliminary review. Scope of design as expressed during our walk through and the provided previous "2016 Concepts".

- D. <u>Meeting Presentations</u>: Preparation of plan graphics and presentation format for 2 meetings/hearings: Present to Parks Committee and GCSD Board Meetings.
- E. Miscellaneous: Administration, coordination, clerical services.

#### 2. Deliverables

- A. <u>Site Analysis and Constraints Map:</u> indicating physical, environmental or legal constraints such as setbacks, easements, utilities, severe slopes, existing trees, neighborhood impacts, traffic, prevailing winds, solar orientation, etc. and their resultant design constraints. Consolidated photo images of existing site and adjacent conditions and constraints.
- B. <u>Concept Plans and Graphics:</u> 2-3 Concept Design Plans indicating options and approaches for the layout of use spaces, activities, pathways, plant material species and types.
- C. <u>Design Images</u>: Photos and images of options for paving materials, furniture, plant material, park equipment or other design related images

#### El Granada Median Trails Master Plan Project Request for Proposals

#### **Background**

El Granada's unique concentric-circle street layout was designed by the influential architect and city planner Daniel Burnham. Burnham's plan for El Granada was commissioned by the Ocean Shore Railroad which developed El Granada as a seaside "resort" for visitors from San Francisco after the 1906 earthquake. The street layout includes several broad avenues featuring wide medians, originally intended as a trail system throughout the resort (see attached Medians Map).

Granada Community Services District (GCSD), previously the Granada Sanitary District, gained park and recreational jurisdiction in the unincorporated areas of El Granada, Miramar and Princeton by voter approval effective October 1, 2014. This reorganization allows the district to provide park and recreation services in addition to the sewer and garbage services it currently provides to ratepayers. The parks and recreation function is funded by utilizing a portion of GCSD's share of property tax revenues.

Following the reorganization of GCSD, a Granada Park Advisory Committee (GPAC) was established to provide the GCSD Board guidance on future park improvements. GCSD's goal is to provide parks and recreation services to Miramar, El Granada and Princeton, with a commitment to leveraging robust community outreach to develop and implement projects benefitting GCSD residents.

In 2015, GCSD completed a "Community Interest and Opinion Survey for Local Parks and Recreation Facility Priorities." Summary of Key Findings relevant to this RFP:

- 76% of the entire GCSD Community<sup>1</sup> and 81% of respondents from El Granada indicated Yes or Maybe, the median strips in El Granada should be improved
- Unpaved Paths/Trails are preferred over Paved Paths/Trails
- Additional community outreach suggested that residents value the rural and natural look and feel of the medians, and strongly prefer natural soil, crushed granite or wood chip trail surfaces to paved surfaces.

#### Scope of Work

The GCSD is seeking a Landscape Architecture firm (Consultant) to assist with median improvement designs for 24 medians (see attached Medians Map). We need the help of a professional design firm to provide a conceptual site plan for each median, including trails, landscaping and seating and to propose, where suitable to the space and supported by community outreach, a small number of recreational options for specific medians. The planning process must include robust community outreach as well as tree management planning. The Consultant would have primary responsibility for planning and conducting community outreach to scope the project and identify preferred alternatives, with assistance from GPAC. The Consultant must produce all presentation materials, which may include posters, email blasts, power-point slides, etc. The final Project Plan alternatives and costs must be presented to the GCSD Board and GPAC within 180 days of granting the contract.
