Call to Order

The Special meeting of the Park Advisory Committee was called to order at 7:05 pm.

ACTION: Pollard moved to approve the meeting minutes of 3/19/18. (Pollard/___). Approved 7-0.

2. Consider Draft Parks Newsletter.

Chair Tierney provided background on this Item, and the Committee reviewed the draft newsletter presented by the Newsletter and Webpage Sub-committee of Tierney and Marsh.

In attendance, Board Director Barbara Dye, stated there should be a process for creating and approving the newsletter, which will be discussed by the Board Communications Ad Hoc Committee. She suggested a joint meeting of the Board and PAC committees. A discussion followed.

ACTION: Koelsch moved to approve the newsletter for presentation with the changes discussed. (Koelsch/Ross). Approved 7-0.

3. Consider Draft Parks Webpage.

The Committee reviewed the draft webpage presented by the sub-committee. Director Dye suggested redesigning and local hosting of the website, which is currently managed by Dudek and Assoc. in San Diego at no cost to the District.

Hi Chuck and Delia,

Yesterday I spoke with Seth Cole, the Senior Vice President of Alliant Insurance Services to inquire about our insurance coverage over the proposed parks activities. He explained to me that most of the activities that we have proposed under our parks powers will be covered by our insurance, as long as they are not listed as exclusions in our policy. He explained to me that the medians improvements will be covered as well as most of the low-risk activities with adults or supervised minors. In addition, volunteers are covered under our insurance. However, there are certain high-risk activities which may not be covered. A high-risk activity is any activity where someone can be seriously injured. To determine whether a high-risk activity is covered, we have to provide a written description of the activity for the CSRMA Board. The CSRMA Board will then vote on whether to cover the activity. If they determine that it is not covered, we will be required to obtain supplemental insurance. I inquired about specific activities that have been proposed. He said that they view a pump track as a high-risk activity that will have to go to their Board. He also identified the edible plant talk as a high-risk activity. In addition, he explained that they would like more information on the activities we have proposed with unsupervised minors. He said that for any adult volunteer working with children we should conduct a background check. In discussing these types of activities, he emphasized that any situation with an adult and an unsupervised minor poses a risk. I believe that Bill recommended that you have a mandated reporter at these events. I would also recommend that we adopt a policy on employee and volunteer interaction with youth. Furthermore, he noted that while volunteers are covered, independent contractors are not covered under our insurance, so we should continue our practice of requiring them to show proof of insurance. I plan to follow-up on my call with an email to Seth, summarizing my understanding of our discussion and requesting his confirmation before we take this recommendation to the Board.

Granada Community Services District (GCSD)

Granada Community Services District (GCSD), formerly the Granada Sanitary District, gained park and recreational jurisdiction in the unincorporated areas of El Granada, Miramar and Princeton (i.e. the "GCSD Community") by a positive vote of 60% of the voters in the District. This change went into effect on October 1, 2014. This reorganization allows the district to provide park and recreation services in addition to the sewer and garbage services it currently provides to ratepayers. The parks and recreation function is funded by utilizing a portion of GCSD's share of property tax revenues, not from sewer charges. GCSD's goal is to provide parks and recreation services to the GCSD community, with a commitment to leveraging robust neighborhood outreach to develop and implement projects benefitting GCSD residents.

The District is also responsible for the sewage collection system and disposal for approximately 2,500 residences and businesses in the District as well as the northern portion of the City of Half Moon Bay. Garbage and recycling services are provided by Recology of the Coast under a franchise agreement with the Granada Community Services District.

GCSD owns the undeveloped "Burnham Strip" property along

Obispo Street between Coronado Street and Avenue Alhambra in El Granada, and a small parcel on Capistrano Road in Princeton. Additional potential park areas are the medians in El Granada, which are owned by SMC. In February

2018, GCSD completed a Permit Agreement with SMC which allows the District to make certain improvements to the El Granada Medians. GCSD may implement landscaping, seating, tree management, and active and passive recreational improvements on these properties, following an open and transparent community outreach process.

Granada Parks Advisory Committee (PAC)

The PAC was set up by the Granada Community Service Board to help with ensuring community involvement in all phases of park planning, design and development. Seven voting members are appointed by the Board to serve two-year terms. Members receive no compensation – they are neighbors volunteering to support and benefit our community. The PAC makes recommendations to the GCSD Board of Directors. PAC meetings and held at the GCSD office at least once each quarter and are open to the public and televised. In 2015, GCSD completed a "Community Interest and Opinion Survey for Local Parks and Recreation Facility Priorities." This survey was mailed to residences in the district and made available online. A total of 609 responses were received. Key findings include:


- 73% of the GCSD Community said Yes or Maybe that local parks need improvement
- 76% of the GCSD Community and 81% of respondents from El Granada indicated *Yes* or *Maybe*, the median strips in El Granada should be improved
- 61% of the GCSD Community indicated a moderate to substantial need for Small Neighborhood Parks, including 78% of households with children
- 65% of the GCSD Community said *Yes* they would participate in more recreational activities if they were available locally
- 66% of the GCSD Community indicated it is moderately or very important to have a Community Center.

PRIORITIZED PARKS AND RECREATION NEEDS LIST * APPROVED BY GCSD PARKS ADVISORY COMMITTEE ON 4/10/18 For Recommendation to the Board of Directors

The following parks and recreation needs for 2018 were identified by the GCSD Parks Advisory Committee (PAC) and prioritized by vote of the committee. We took a one-year perspective, so actions such as a community center were not shown in this list because they were years in the future. The PAC is very interested in seeing recreation facilities built, communications about parks and recreation improved and programs enhanced this year.

- 1. Develop an RFP for plans and outreach for small neighborhood active park or playground in median 7, 8, and/or 11, and submit as soon as possible.
- 2. Lease land from CUSD and develop a bike pump track on the El Granada surplus property
- 3. Replace benches and picnic tables at key locations in the medians
- 4. Develop RFP for a trail and amenities plan for all El Granada medians, with first implementation on median #11 (Portola), as soon as possible.
- 5. Create and implement a parks and recreation webpage on the GCSD website
- 6. Write a recreation-focused GCSD newsletter and have it mailed to all district residences
- 7. Identify and promote 6-12 short (1/2 day) special events for summer 2018 organized by the PAC and sponsored by the district
- 8. Protect the Burnham Strip with signs and approve plans for resource protection and recreational improvements
- 9. Liaison with County Parks on Quarry Park plan and pump track
- 10. Plan and develop a small disc golf course
- * Several PAC members mentioned that they did not consider the recreation newsletter, parks and recreation webpage and summer special events when compiling these priorities "since these were well along the way to be completed," and the committee had already passed motions to recommend them to the Board, and this may have lowered the ranking of those three tasks.

We purposefully kept some items separate, even though they are related, so the Board could more clearly see our priorities and allow them to be combined later in the process.
